ITEM 1. SECURITY AND ISSUER

The class of securities to which this statement relates is common stock, par value \$.0001 per share (the "Common Stock") of Golden West Brewing Company, Inc., a Delaware corporation (the Company). The address and principal executive offices of the Company is 945 West 2nd Street, Chico, California 95928.

ITEM 2. IDENTITY AND BACKGROUND

(a)-(c) John D. Gibbs; 807 Wooden Creek, Ardmore, OK 73041, President of TriPower Resources, 16 E. Street SW, Ardmore, OK 73401.

(d)-(f) The natural person referred to above is a United States Citizen. During the last five years, he has not been (i) convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) or (ii) has been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Effective March 14, 2007, Mr. Gibbs acquired an aggregate of 300,000 shares of common stock and warrants exercisable to purchase an additional 300,000 shares of common stock, for cash consideration of \$0.35 per Unit, or, total cash consideration of \$105,000. Wyoming Resorts, LLC, of which Mr. Gibbs is a control person, acquired 220,000 shares for \$110,000 in cash in the Company's public offering which closed in August, 2006.

ITEM 4. PURPOSE OF TRANSACTION

The securities of the Company were acquired by Mr. Gibbs for investment. Mr. Gibbs reserves the right to acquire additional shares of the Company's common stock, either in open market purchases or in private transactions.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

(a) At the close of business on March 23, 2007, Mr. Gibbs would be deemed the beneficial owner, within the meaning of Rule 13d-3 under the Exchange Act, of an aggregate of 820,000 shares of common stock. Those securities consist of (i) 300,000 shares of common stock and warrants exercisable to purchase an additional 300,000 shares of common stock owned by Mr. Gibbs, individually and, (ii) an aggregate of 220,000 shares of common stock owned of record by Wyoming Resorts, LLC, of which Mr. Gibbs is a control person and, therefore, exercises voting and investment power with respect to those securities. The securities represent 25.9% of the issued and outstanding shares of common stock of the Company. The foregoing is based upon 2,818,000 shares of common stock issued and outstanding as of the date of this report.

(b) Mr. Gibbs has the sole voting and dispositive power with respect to all of the shares of common stock identified in Item 5(a) above, except as noted.

(c) Mr. Gibbs has not purchased or sold any shares of common stock during the past 60 days, except as noted.
