- Luxor Capital Partners Offshore, Ltd., a Cayman Islands exempted company (the “Offshore Feeder Fund”);
- LCG Holdings, LLC, a Delaware limited liability company (“LCG Holdings”);
- Luxor Capital Group, LP, a Delaware limited partnership (“Luxor Capital Group”);
- Luxor Management, LLC, a Delaware limited liability company (“Luxor Management”); and
- Christian Leone, a United States citizen (“Mr. Leone”).

The Offshore Master Fund is a subsidiary of the Offshore Feeder Fund. LCG Holdings is the general partner of the Onshore Fund, the Wavefront Fund and the Offshore Master Fund. Luxor Capital Group acts as the investment manager of the Onshore Fund, the Wavefront Fund, the Offshore Feeder Fund and the Offshore Master Fund (collectively, the “Funds”). Luxor Management is the general partner of Luxor Capital Group. Mr. Leone is the managing member of Luxor Management. Mr. Leone is the managing member of LCG Holdings.

By virtue of these relationships, LCG Holdings may be deemed to have voting and dispositive power with respect to the shares of Class A Common Stock (as defined below) owned directly by the Onshore Fund, the Wavefront Fund and the Offshore Master Fund. By virtue of these relationships, each of Luxor Capital Group, Luxor Management and Mr. Leone may be deemed to have voting and dispositive power with respect to the shares of Class A Common Stock beneficially owned by the Funds.

(iv) LCG Holdings, as the general partner of the Onshore Fund, the Wavefront Fund and the Offshore Master Fund, may be deemed to have beneficially owned the 999,597 shares of Class A Common Stock beneficially owned by the Onshore Fund, the Wavefront Fund and the Offshore Master Fund;

(v) Luxor Capital Group, as the investment manager of the Funds, may be deemed to have beneficially owned the 999,597 shares of Class A Common Stock beneficially owned by the Funds;

(vii) Mr. Leone, as the managing member of Luxor Management, may be deemed to have beneficially owned the 999,597 shares of Class A Common Stock beneficially owned by Luxor Management.
