The selling holders purchased the notes in private transactions on or after October 27, 2000. All of the notes were restricted securities under the Securities Act prior to this registration.

In addition, the conversion rate and therefore, the number of shares of common stock issuable upon conversion of the notes, is subject to adjustment under certain circumstances.
