- On January 24, 2018, the reporting person filed a Form 4 reporting the sale of 513 shares of common stock that were erroneously sold by the broker. The sale of the 513 shares was unwound through the broker's error account and therefore did not occur for purposes of the reporting person's account. This amended Form 4 deletes the foregoing transaction which was reported on the fifth line of Table 1 in the original Form 4 filing.
