Item 4.01. Changes in Registrant's Certifying Accountant.

On July 19, 2005, we decided to engage new auditors as our independent accountants to audit our financial statements. Our Board of Directors approved the change of accountants to Mintz and Partners LLP, an independent registered firm of Certified Public Accountants.

During our two most recent fiscal years, and any subsequent interim periods preceding the change in accountants, there were no disagreements with Lopez, Blevins, Bork & Associates, LLP on any matter of accounting principles or practices, financial statement disclosure, or auditing scope procedure. The report on the financial statements prepared by Lopez, Blevins, Bork & Associates, LLP, for either of the last two years did not contain an adverse opinion or a disclaimer of opinion, nor was it qualified or modified as to uncertainty, audit scope or accounting principals, except that Lopez, Blevins, Bork & Associates, LLP expressed in their report substantial doubt about our ability to continue as a going concern. The decision to change accountants was based on the determination by

the Board of Directors that such a step was necessary in order that our auditors be located in the same region as our head offices and as such be more accessible to the company.

We provided Lopez, Blevins, Bork & Associates, LLP with a copy of this Current Report on Form 8-K prior to its filing with the SEC, and requested that they furnish us with a letter addressed to the SEC stating whether they agree with the statements made in this Current Report on Form 8-K, and if not, stating the aspects with which they do not agree. A copy of the letter provided from Lopez, Blevins, Bork & Associates, LLP dated July 19, 2005 is filed as Exhibit 16 to this Form 8-K.

We have engaged the firm of Mintz and Partners LLP, as of July 19, 2005. Mintz and Partners LLP was not consulted on any matter relating to accounting principles to a specific transaction, either completed or proposed, or the type of audit opinion that might be rendered on our financial statements.
