Item 1.01. Entry into a Material Definitive Agreement.

On September 13, 2005, Spirit Finance Corporation (the "Company") entered into a \$200 million revolving secured credit facility with Citigroup Global Markets Realty Corp. The facility is structured as a master loan repurchase arrangement ("Repurchase Agreement") and the Company's borrowings under the facility will be secured by mortgages on specific properties owned by the Company or acquired in the future and pledged as collateral under the facility. The facility is a revolving facility and allows the Company to continually borrow under the facility, subject to maximum limits, during its one year term and does not have any prepayment penalties. The facility contains customary financial and restrictive covenants for borrowings of that type. A copy of the Repurchase Agreement is attached hereto as Exhibit 10.1, and incorporated herein by reference.
