On November 29, 2010, Martin H. Loeffler confirmed to Amphenol Corporation (the Company) and to the Company s Board of Directors that he will retire as Executive Chairman of the Company effective January 1, 2011. The Board of Directors has approved the payment of an annual retainer fee in the amount of \$150,000, payable quarterly, for his continuing services as non-executive Chairman of the Board of Directors.
