(1) The reporting person tendered 380.5 shares of common stock of PPG Industries, Inc. ("PPG") in the exchange offer commenced by PPG on December 27, 2012 in exchange for 3.2562 shares of common stock of Eagle Spinco Inc. ("Splitco"), which is adjusted by a preliminary proration factor of 14.32%. In connection with the previously announced merger of a wholly owned subsidiary of Axiall Corporation with Splitco, each share of Splitco common stock received by the reporting person in the exchange offer converted automatically into one share of Axiall Corporation common stock. The number of shares of Axiall Corporation common stock set forth above to be acquired by the reporting person represents an estimate and is subject to change as a result of the final proration factor to be announced by PPG. The reporting person undertakes to amend this report as necessary upon the determination of the final proration factor.
