**Item 5.03. Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.**

*Change of Corporate Name*

Effective on August 28, 2017, KII Liquidating Inc. (formerly Katy Industries, Inc.) (the Company) amended its certificate of incorporation to change its name from Katy Industries, Inc. to KII Liquidating Inc. The name change was effected pursuant to an amendment to the certificate of incorporation of the Company, which was filed with the Secretary of State of the State of Delaware on August 28, 2017.

**Item 8.01. Other Events.**

As previously disclosed, on May 14, 2017, the Company and certain of its wholly-owned direct and indirect domestic subsidiaries (collectively with the Company, the Debtors) filed voluntary petitions in the United States Bankruptcy Court for the District of Delaware (the Bankruptcy Court) seeking relief under Chapter 11 of Title 11 of the United States Code (the Bankruptcy Code). These cases (the Chapter 11 Cases) are being jointly administered under the caption *In re Katy Industries, Inc., et al.*, Case No. 17-11101. The Debtors continue to operate their businesses as debtors-in-possession under the jurisdiction of the Bankruptcy Court and in accordance with the applicable provisions of the Bankruptcy Code and orders of the Bankruptcy Court.

On September 14, 2017, the Debtors filed their monthly operating report for the period of July 1, 2017 July 28, 2017 (the Monthly Operating Report) with the Bankruptcy Court. The Monthly Operating Report is attached hereto as Exhibit 99.1 and is incorporated herein by reference.

The Monthly Operating Report also contains information for periods which are shorter and otherwise different from those required in the Company's periodic reports pursuant to the Securities Exchange Act of 1934, as amended (the Exchange Act), and such information might not be indicative of the Company's financial condition or operating results for a period that would be reflected in the Company's financial statements or in its reports pursuant to the Exchange Act. Information set forth in the Monthly Operating Report should not be viewed as indicative of future results.
