These units of restricted stock will be settled one-for-one in shares of common stock upon vesting, provided that the reporting person remains an employee of the company on the vesting date.
 - (4) Grant date 12/15/08; time based restricted stock units that will vest over a five-year period from the date of the grant as follows: 20% on the third anniversary of the grant; 20% on the fourth anniversary of the grant; and 60% on the fifth anniversary of the grant. These units of restricted stock will be settled one-for-one in shares of common stock upon vesting, provided that the reporting person remains an employee of the company on the vesting dates.
