Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an equal number of shares of PG&E Corporation common stock following termination of employment.

- (4) Restricted Stock Units granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP). Restricted Stock Units are payable in shares of PG&E Corporation common stock on a one-for-one basis.

These holdings have been trued up to conform to the RSP balance at March 6, 2009 and reflect the acquisition of approximately 93.33 shares on January 15, 2009 due to dividend reinvestment.
