- (1) The sale reported in this Form 4 was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on April 29, 2013. The total amount of securities reported as indirectly owned by the reporting person represents a reduction of .0666 shares allocated to the reporting person's account in the Company's 401(k) Plan as of July 31, 2013.
