(1) The common shares of beneficial interest were sold pursuant to a 10b5-1 plan in order to pay estimated tax obligations resulting from the vesting of 600 restricted share units on August 4, 2013.

(2) The reported amount consists of 37,400 restricted share units and 25,925 common shares of beneficial interest. The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting. On August 4, 2013, 600 restricted units vested and were settled in common shares of beneficial interest, of which 300 were sold as described in the preceding footnote and 300 are included in the reported amount.
