**Breakthrough Television Series "The Tudors" Earns Two Emmy® Award Nominations for Showtime, Peace Arch® Entertainment
and TM Productions**

TORONTO July 17, 2008 -- Peace Arch® Entertainment Group Inc. (AMEX:[PAE](#) - [News](#)) (Toronto:[PAE.TO](#) - [News](#)), an integrated global entertainment company, announced today that the Company's television series "The Tudors" received two Creative Emmy® Award nominations from the Academy of Television Arts & Sciences. The nominations are for "Outstanding Costumes for a Series" and "Outstanding Casting for a Drama Series" for the second season of the critically acclaimed program.

A.

Rule as to Use of Form 6-K,
