The restricted stock units (RSUs) are released as they vest. A total of 25% of the entire number of shares subject to this RSU grant

- (1) become vested and are released on the first anniversary of the vesting commencement date and the remaining shares subject to this RSU vest and are released at a rate of 25% a year on each anniversary of the vesting commencement date over the remaining three years.
- (2) The shares are held in the Carlsted Family Trust.
- (3) These options are exercisable as they vest. The shares subject to this stock option become vested and fully exercisable in equal monthly installments, ratably over a period of 48-months, beginning on October 1, 2010.
