ClearOne Communications, Inc. (the "Company") is unable to file the transition report on Form 10-K for the transition period ended December 31, 2009 (the "Form 10-K") by the prescribed filing deadline of March 31, 2010 without unreasonable effort and expense. The Company acquired NetStreams, Inc. on November 3, 2009 and has expended considerable resources and time in integrating the operations of the company and to gather and process financial information for reporting for the transition period. The Company will need additional time to complete the required reporting including accounting for acquisition. The Company expects to file the Form 10-K for the transition period ended December 31, 2009 as soon as practicable and no later than 15th calendar day following the prescribed due date.

The Company expects to report a net income for the transition period of six months ended December 31, 2009 of approximately \$0.1 million on revenues of approximately \$16.8 million, as compared to a

net income for six months ended December 31, 2008 of \$2.3 million (restated) on revenues of \$21.0 million (restated). The decrease in net income is primarily due to reduction in revenues and margin due to a slow down in the economy and due to higher legal expenses. While the Company does not expect the audited results for the transition period ended December 31, 2009 to materially differ from those reported above, since the Company has not completed the audit for the transition period ended December 31, 2009 the audited results ultimately reported in Form 10-K may differ from those reported above.
