LP Units are redeemable for an equal number of Common Shares of Kite Realty Group Trust ("Kite") or, at the election of Kite, cash equal to the fair market value of such shares. As noted in Footnote 2 above, units have no expiration date and are all currently redeemable for Common Shares or cash at the election of Kite.
