- (1) Award reflects (i) 36,000 shares of restricted common stock granted pursuant to the issuer's 2009 Equity Incentive Plan; and (ii) 11,000 shares of restricted common stock granted pursuant to the issuer's 2009 Equity Incentive Plan, which shares were issued in lieu of a portion of the executive's cash bonus award under the issuer's Incentive Bonus Plan. One-third of the awarded shares will vest on each of the first three anniversaries of the grant date, with the first tranche vesting on December 17, 2011.
