Each of KCMLP and Knoll beneficially own 3,055,357 Shares of the Issuer's Common Stock, which is comprised of 2,034,949 Shares of the Issuer's Common Stock and warrants to purchase 1,020,408 shares of Common Stock. KCMLP has trading authority for Gakasa, and Knoll is the President of KCMLP.

(b) Percent of Class:

The 3,055,357 shares of the Issuer's Common Stock beneficially owned by each of Gakasa, KCMLP and Knoll constitute 2.6% of the Issuer's Common Stock outstanding.

This percentage is calculated based on a total of 116,652,351 shares of Common Stock outstanding, as reported by the Issuer's November 15, 2016 Prospectus.
