(21,500 shares), Summer Street Life Sciences Hedge Fund Investors LLC (91,000 shares), Knightsbridge Post Venture IV L.P. (16,400 shares), Knightsbridge Netherlands II, L.P. (6,300), Knightsbridge Netherlands III - LP (11,000 shares), Knightsbridge Venture Capital VI, L.P. (21,300 shares), Biotech Growth Trust plc (173,900 shares), and Stichting Pensioenfonds ABP (263,400 shares).

The reporting persons are a party to certain cash settled over the counter swap agreements which synthetically provides additional long exposure to the Issuer, and as a result, the reporting persons are entitled to the economic benefits, and are subject to the economic risks, of owning the Common Stock, but have no rights, powers, agreements, arrangements or understandings with respect to any shares of Common Stock as a result of those agreements.
