- (2) Reflects additional phantom stock units received by the Reporting Person upon conversion of dividend equivalents from December 31, 2008 to the present.
- (3) Of the shares being reported, 11,500 shares are subject to certain restrictions (including possible forfeiture) applicable to restricted stock grants under the 2000 Stock Incentive Plan and the Restricted Stock Award Agreements.
