- On March 23, 2010, the Reporting Person sold an aggregate of 60,000 shares of common stock of iStar Financial Inc. at an average price of \$4.9887 per share, as follows: 38,818 shares were sold on behalf of a family trust and 21,182 shares were sold on behalf of an individual retirement account established by the Reporting Person. Following this transaction, the Reporting Person beneficially owns a total of 40,000 shares of iStar common stock, consisting of 28,000 shares owned indirectly in an individual retirement account established by the Reporting Person and 12,000 shares owned indirectly as trustee of a family trust.
