- (1) On April 10-12, 2013, a total of 80,246 shares of iStar common stock (26,749 shares on each day) were sold on behalf of the Reporting Person, Mr. Jay Sugarman, in open market transactions pursuant to a Rule 10b5-1 sales plan adopted by the Reporting Person on March 22, 2013. Following the transactions reported in this Form 4, the Reporting Person is the direct beneficial owner of 2,651,922 shares of iStar common stock and the indirect beneficial owner of 44,544 shares of iStar common stock owned by his spouse.
