Dividend equivalent rights accrue with respect to the unvested RSUs when and as dividends are paid on Hexcel common stock. The 5.71 dividend equivalent rights reflect dividend equivalent rights at \$44.22 per RSU owned by the reporting person on the record date and credited to the reporting person's account on August 11, 2016.

(5) As previously reported, on January 26, 2016, the reporting person was granted 3,805 RSUs. Dividend equivalent rights accrue with respect to the unvested RSUs when and as dividends are paid on Hexcel common stock. The 9.56 dividend equivalent rights reflect dividend equivalent rights at \$44.22 per RSU owned by the reporting person on the record date and credited to the reporting person's account on August 11, 2016.
