The 226.1727 dividend equivalent rights being reported reflect 226.1727 dividend equivalent rights at \$21.40 per RSU credited to the reporting person's account on 10/02/13.
- (3) As previously reported, on 12/06/12 the reporting person was granted 40,000 restricted stock units ("RSUs"), 13,333 of which vested on 12/06/13, 13,333 of which will vest on 12/06/14, and 13,334 of which will vest on 12/06/15.
