- (4) On 07/29/15 the Issuer announced approved amendments to certain outstanding long-term incentive awards that were originally scheduled to vest between 09/18/15 and 12/31/15, to provide for the accelerated vesting on 10/01/15.

- As previously reported, on 12/11/13 the reporting person was granted 55,175 performance adjusted restricted stock units ("PARSUs"), 50% of which vested early on 10/01/15, and 50% of which will vest on 12/11/16, in each case subject to certain return on invested capital performance conditions and/or relative total stockholder return conditions being met at the time of vesting. Dividend equivalent rights accrue with respect to these PARSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 947.8194 vested dividend equivalent rights accrued but not released since the grant date, and a de minimus adjustment of 0.1382 due to fractional rounding of the dividend equivalent rights.
