- Acquired pursuant to the First Amended and Restated Agreement and Plan of Merger, dated as of September 3, 2010 (the "Merger Agreement"), by and among Inergy, L.P. ("Inergy"), Inergy GP, LLC, Inergy Holdings, L.P. ("Holdings"), Inergy Holdings GP, LLC, NRGP Limited Partner, LLC and NRGP MS, LLC. Acquired 16,265 common units representing limited partner interests in Inergy on November 5, 2010 pursuant to the Merger Agreement in exchange for 21,123 Holdings common units. On the effective date of the merger, the closing sales price of Holdings common units on the NYSE was \$30.71, and the closing sales price of Inergy common units on the NYSE was \$39.95 per unit.
  - Acquired pursuant to the Merger Agreement in exchange for 52,020 Holdings common units on November 5, 2010. Any fractional units of Inergy will be paid in cash.
