Such 25,000 share grant vests at the following rate: 1/4th of such shares on November 10, 2010 and on each one year anniversary thereafter.
 - (3) The 2,597 shares were sold through separate trades, with the sale prices ranging from \$8.84 to \$8.88 and at a weighted average sale price of \$8.857.
