On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, and pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, this option which was previously reported as an option for 24,792 shares of common stock at an exercise price of \$33.72 per share, was adjusted to 49,584 shares of common stock at an exercise price of \$16.86 per share.
