PVF Holdings LLC ("PVF") owns 84,214,026 shares of common stock, par value \$0.01 per share ("Common Stock"), of MRC Global Inc. (the "Company"). Mr. Bond owns 6.3552 common units ("Common Units") of PVF, representing 0.002% of the total outstanding Common Units. Mr. Bond may be deemed to beneficially own 1,603 shares of Common Stock indirectly through his ownership of such

(1) Common Units. The Amended and Restated Limited Liability Company Agreement of PVF, dated as of October 31, 2007 (the "LLC Agreement"), Amendment No. 1 to the LLC Agreement, dated as of December 18, 2007, and Amendment No. 2 to the LLC Agreement, dated as of October 31, 2009, are filed as exhibits 10.17, 10.17.1, and 10.17.2 to the Company's Registration Statement on Form S-1, File No. 333-178980.

Mr. Bond does not have the power to vote or dispose of the shares of Common Stock that correspond to his ownership of Common Units and thus does not have beneficial ownership of such shares. In addition, Mr. Bond does not have any pecuniary interest in the shares of

(2) Common Stock held by PVF because he does not control PVF and does not have or share investment control over the shares of Common Stock owned by PVF.

(3) 33 1/3% of the options reported above became exercisable on 6/16/2011; and 33 1/3% of the options reported above will become exercisable on each of 6/16/2012 and 6/16/2013.

(4) 33 1/3% of the options reported above will become exercisable on each of 12/3/2012, 12/3/2013, and 12/3/2014.

(5) 20% of the options reported above will become exercisable on each of 11/10/2012, 11/10/2013, 11/10/2014, 11/10/2015, and 11/10/2016.
