Each share of Class B Common Stock is convertible at any time at the option of the Reporting Person into one share of Class A Common Stock and has no expiration date. All Class A Common Stock and Class B Common Stock will convert automatically into Common Stock on the earlier of (i) the date on which the number of outstanding shares of Class B Common Stock represents less than 10% of the

(1) aggregate combined number of outstanding shares of Class A Common Stock and Class B Common Stock and (ii) seven years following the effective date of the Issuer's initial public offering. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock (i) upon any transfer, whether or not for value (subject to certain exceptions), or (ii) in the event of the death or disability (as defined in the amended and restated certificate of incorporation of the Issuer) of the Reporting Person.

(2) On February 15, 2013, Bessemer Venture Partners VI, L.P. ("BVP VI") sold 13,176 shares, Bessemer Venture Partners Co-Investment LP ("BVP Co-Investment") sold 5,406 shares and Bessemer Venture Partners VI Institutional L.P. ("BVP Institutional," and together with BVP VI and BVP Co-Investment, the "Funds") sold 318 shares at the weighted average sale price of \$22.0008 (the "February 15 Fund Sales").

(3) After the February 15 Fund Sales, BVP VI owned 6,030,650 shares, BVP Co-Investment owned 2,474,293 shares, and BVP Institutional owned 145,311 shares of Class B Common Stock.

(4) Mr. Levine is a managing member of Deer Management Co. LLC, the management company affiliate of the Funds. Mr. Levine disclaims beneficial ownership of the securities sold by the Funds and this report shall not be deemed an admission that such Reporting Person is the beneficial owner of such securities, except to the extent of his pecuniary interest therein, if any, by virtue of his interest in Deer VI, the general partner of each of the Funds, and his indirect limited partnership interest in BVP Co-Investment.

(5) On February 19, 2013, BVP VI sold 72,891 shares, BVP Co-Investment sold 25,753 shares and BVP Institutional sold 1,756 shares at the weighted average sale price of \$22.2429 (the "February 19 Fund Sales").

(6) After the February 19 Fund Sales, BVP VI owned 5,957,759 shares, BVP Co-Investment owned 2,448,540 shares, and BVP Institutional owned 143,555 shares of Class B Common Stock.

(7) On February 20, 2013, BVP VI sold 28,476 shares, BVP Co-Investment sold 8,438 shares and BVP Institutional sold 686 shares at the weighted average sale price of \$22.03 (the "February 20 Fund Sales").

(8) After the February 20 Fund Sales, BVP VI owned 5,929,283 shares, BVP Co-Investment owned 2,440,102 shares, and BVP Institutional owned 142,869 shares of Class B Common Stock.
