(1) Grant of restricted stock units. The restricted stock units vest in three equal installments: March 1, 2014; March 1, 2015; and March 1, 2016.

(2) Includes the following purchases under the Chemtura Corporation Employee Stock Purchase Plan subsequent to the date of the reporting person's most recent filing on Form 4 providing Table I information: 237 shares on September 28, 2012; 168 shares on December 31, 2012.
