- (1) Each share of common stock was disposed of in exchange for a cash payment of \$12.25 per share upon the consummation of the merger (the "Merger"), contemplated by that certain Agreement and Plan of Merger, dated December 31, 2012, by and among Avis Budget Group, Inc., Millennium Acquisition Sub, Inc. and Zipcar, Inc.
- (2) Shares held by the Sweetwater Trust, of which Ms. Whitman is a trustee. Ms. Whitman disclaims beneficial ownership of such shares except to the extent of her pecuniary interest therein.
- (3) Prior to the effective time of the Merger, all outstanding options were accelerated, became fully vested and were cancelled in exchange for a cash payment equal to the product of (i) \$12.25 less the exercise price per share of the option multiplied by (ii) the total number of shares underlying the option.
