(1) These Ordinary Shares were sold in multiple transactions at sales prices ranging from \$50.6214 to \$50.6600, inclusive. (3) Options granted to the Reporting Person under the Seagate Technology's 2004 Stock Compensation Plan are subject to four-year vesting schedule. One quarter of the option shares vested on September 12, 2012. The Remaining options vest monthly over the 36 months following September 12, 2012.

(4) Options granted to the Reporting Person under the Seagate Technology plc 2012 Equity Incentive Plan (the "Plan") are subject to a four year vesting schedule. One quarter of the options vested September 10, 2013. The remaining options vest in equal monthly installments over the 36 months following September 10, 2013.
