Unilever NV announces that on 20 April 2007 it purchased 450,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 22.3288 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 113,862 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 60,196,041 Unilever NV ordinary shares in treasury, and has 1,654,531,659 Unilever NV ordinary shares in issue (excluding treasury shares).
