Unilever NV also announces that 14,682 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 93,673,302 Unilever NV ordinary shares in treasury, and has 1,621,054,398 Unilever NV ordinary shares in issue (excluding treasury shares).
