Unilever NV announces that on 10 October 2007 it purchased 245,309 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.680 and euro 21.800 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 13,014 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 99,176,784 Unilever NV ordinary shares in treasury, and has 1,615,550,916 Unilever NV ordinary shares in issue (excluding treasury shares).
