**Item 2.02. Results of Operations and Financial Condition.**

On November 9, 2007, Aleris International, Inc. (the Company) issued an earnings press release regarding the quarter ended September 30, 2007. In that press release, the Company misclassified an item resulting in an understatement of Cash provided by operating activities, related to an item that should have been included within Net change in operating assets and liabilities. The Company also changed the presentation of the non-cash charges related to the step-up in carrying value for the three and nine months ended September 30, 2006. To correct this error, the Company has made the following changes to the earnings press release:

On page two of the release, Cash flows provided by operating activities for the three months ended September 30, 2007 (Successor) and for the nine months ended September 30, 2007 (Successor) are \$110.2 million and \$210.8 million, respectively;

On page twelve of the release, the Net change in operating assets and liabilities is \$52.6 million for the three months ended September 30, 2007 (Successor), \$40.4 for three months ended September 30, 2006 (Predecessor), \$80.0 million for the nine months ended September 30, 2007 (Successor), and \$(5.3) million for the nine months ended September 30, 2006 (Predecessor); and

On page twelve of the release, Cash provided from operating activities for the three months ended September 30, 2007 (Successor) and for the nine months ended September 30, 2007 (Successor) are \$110.2 million and \$210.8 million, respectively.

On page twelve of the release, Non-Cash charges related to step-up in carrying value of inventory are \$9.1 million for each of the three and nine months ended September 30, 2006 (Predecessor);
