<b>Interest Payment Dates:</b>	Interest will be paid semiannually on June 10 and December 10, beginning on December 10, 2008 to holders of record as of the preceding May 26 and November 25, respectively.
<b>Day Count:</b>	30/360
<b>Use of Proceeds:</b>	The net cash proceeds from the sale will be used for general corporate purposes. Pending such use, we may temporarily invest net proceeds in interest-bearing, investment-grade securities.
<b>Series:</b>	The Notes are part of a series of debt securities entitled Medium-Term Notes, Series A that we may issue under the Indenture. We may re-open this series of Notes, and issue additional Notes of this series under the Indenture in the future.
<b>Exchange Listing:</b>	The Notes will not be listed on any national securities exchange.
<b>Denomination:</b>	We will issue the Notes in denominations of \$1,000 and in integral multiples thereof.
<b>Book-Entry System:</b>	The Notes will be issued only in fully registered form without interest coupons.
