**WHAT IS BEING VOTED ON AT THE SHAREHOLDER MEETING?**

1. The election of all members of the Board of Directors to serve until the Annual Meeting of Shareholders in 2011;
2. Proposal described in the proxy statement to amend the Articles of Incorporation and Code of Regulations to provide for majority voting in uncontested elections of directors;
3. Proposal described in the proxy statement to amend the Articles of Incorporation and Code of Regulations to eliminate cumulative voting in elections of directors;
4. Proposal described in the proxy statement to amend the Code of Regulations to permit the directors to further amend the code of regulations without shareholder consent to the extent permitted by Ohio law;
5. Approval of an advisory vote on executive compensation;
6. Approval of the appointment of the firm of Deloitte & Touche LLP to serve as the independent registered public accounting firm for the Company for the year 2010;
7. Shareholder proposal to request that the Board of Directors adopt a policy that the Chairman of the Board shall be a director who is independent from Fifth Third;
