Sparton Corporation ( Sparton ) issued a press release today announcing that its wholly-owned subsidiary, Sparton BP Medical Denver, LLC, completed its previously announced acquisition of certain assets and assumption of certain liabilities of Byers Peak Incorporated s medical device contract manufacturing business located in Wheat Ridge, Colorado, pursuant an asset purchase agreement with Byers Peak and its shareholders, dated February 18, 2011. Pursuant to the asset purchase agreement, Sparton paid \$4,350,000 to Byers Peak from its existing cash balances. The purchase price remains subject to certain post-closing adjustments.
