**UMB Financial Corporation's Annual Meeting of Shareholders will be held on April 24, 2012 at 1010 Grand Blvd., Kansas City, MO 64106, at 9:00 a.m. Central Time.**

**Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.**

**The Board of Directors recommends that you vote FOR the following proposals:**

1. Election of Directors: Nancy K. Buese, J. Mariner Kemper, Thomas D. Sanders, and L. Joshua Sosland.
2. Ratification of the Audit Committee's retention of Deloitte & Touche LLP to serve as the Company's independent registered public accounting firm and to examine and audit the consolidated financial statements of the Company for the fiscal year 2012.

**The Board of Directors recommends that you vote AGAINST the following proposal:**

3. To act upon a shareholder proposal asking the Board of Directors to adopt a policy, in addition to the Company's current Policy Against Hedging Transactions, that would prohibit named executive officers and directors from engaging in derivative, speculative or hedging transactions. Other business as may properly come before the meeting and any adjournment or postponement thereof involving Company stock, and from pledging Company stock as collateral for a loan.
