(e) On August 27, 2012, Gold Resource Corporation (the Company) entered into a new stock option agreement with Brad Blacketer, the Company's Chief Financial Officer. Mr. Blacketer agreed to cancel his original stock option agreement dated March 16, 2012 issued in connection with the commencement of his employment in exchange for the new stock options having a lower exercise price and subject to a new three-year vesting period. Under the new stock option agreement, Mr. Blacketer has the option to purchase 240,000 shares of the Company's common stock at an exercise price of \$17.64, vesting in equal installments over three years with an option period term of 10 years.
