**Northeast Utilities Annual Meeting of Shareholders will be held on October 31, 2012 at the Sheraton Springfield Monarch Place Hotel, One Monarch Place, Springfield, Massachusetts, 01144 at 2:00 p.m. Eastern Time.**

Proposals to be voted on at the meeting are listed below along with the Board of Trustees' recommendations.

The Board of Trustees recommends a vote **FOR** all nominees and **FOR** Proposals 2, 3 and 4:

1. To elect fourteen nominees as Trustees, the names of whom are set forth in the Company's Proxy Statement, for the ensuing year.
2. To consider and approve the following advisory (non-binding) proposal:

RESOLVED, that the compensation paid to the Company's named executive officers, as disclosed pursuant to the compensation disclosure rules of the Securities and Exchange Commission, including the compensation discussion and analysis, the compensation tables and any related material disclosed in this Proxy Statement, is hereby APPROVED.

3. To re-approve the material terms of performance goals under the 2009 Northeast Utilities Incentive Plan as required by Section 162(m) of the Internal Revenue Code.
4. To ratify the selection of Deloitte & Touche LLP as independent registered public accountants for 2012.
