Goldblatt ( Seymour ) and Kenneth A. Goldblatt ( Kenneth ), both United States citizens. SST and SSCIIM are registered investment advisers. Seymour is the President of each of SST and SSCIIM and owns a majority of the interests in SST. Kenneth owns a majority of the interests in SSCIIM. An agreement among SST, SSCIIM, Seymour and Kenneth in writing to file this statement on behalf of each of them is attached as Exhibit A hereto. This statement relates to shares held for the accounts of multiple private investment funds for which SST or SSCIIM acts as investment adviser.**
