(b) On April 3, 2014, Kenneth T. Stevens notified the Board of Directors (the Board) of Ulta Salon, Cosmetics & Fragrance, Inc. (the <u>Company</u>) that he will not seek re-election as a director of the Board at the Company s 2014 Annual Meeting of Stockholders, scheduled for June 5, 2014 (the <u>Annual Meeting</u>). Mr. Stevens will continue to serve as a director and Non-Executive Chairman until the Annual Meeting. Mr. Stevens resignation is due to the increasing time his other business obligations require and is not because of a disagreement on any matter relating to the Company s operations, policies or practices.

The Board has appointed Charles J. Philippin, a member of the Board since 2008, as Non-Executive Chairman of the Board upon the completion of Mr. Stevens term, subject to the re-election of Mr. Philippin at the Annual Meeting.
