Covidien Chairman, President & CEO Joe Almeida, and Medtronic Chairman and CEO Omar Ishrak are scheduled to visit seven Covidien sites and several Medtronic sites over the coming months to meet with employees and discuss the proposed Covidien acquisition. Omar will also discuss the Covidien acquisition at his next [Global Employee Town Hall](#) scheduled for August 22, 2014.

July 9, 2014 marked the first time the leaders jointly addressed Covidien employees since Medtronic announced its plans to acquire Covidien. Over 600 Covidien employees from the New and North Haven, Conn., U.S. locations attended a Town Hall hosted by the two CEOs.

Omar took time to explain the Medtronic Mission, which has remained unchanged since its creation in 1960 to alleviate pain, restore health and extend life. He also underscored Medtronic's strong commitment to patients and expressed pride and excitement at the prospect of the two companies making a difference together.

As a combined company, we will have the ability to positively impact the lives of more patients around the world than ever before, Omar said.

Joe Almeida took the stage telling Covidien employees he was very excited to be hosting the meeting from Connecticut, a location vitally important in the history of our Company, with a strong track record of innovation.

The CEOs then moved to the North Haven location for a tour of the Covidien facility, giving Omar the chance to meet Covidien employees from several functions.
