Accelerating Growth

Co-leaders of the Growth Acceleration integration planning workstream, Ellie Pidot (Medtronic) and David Wang (Covidien), share how they are identifying opportunities to accelerate growth of the combined company after the acquisition closes.

Question: What is the purpose of the Growth Acceleration workstream team?

Ellie: Our charter is to identify revenue growth opportunities for the newly-combined organization post-close. We're looking for ways to accomplish things neither company could do independently. Some ideas are going to be very practical and tangible, and others will be more transformational in nature. Our scope is to cover both.

David: Essentially we are identifying how our combined efforts can transform health care over the long-term.

Question: How are you identifying and prioritizing growth acceleration opportunities?

David: We started by interviewing leaders across both companies. This helped us identify activities we can fold into integration planning and other strategies that will begin on or after close.

Ellie: Some of the opportunities have a clear owner and process where the idea can naturally live post-close. We also have ideas that do not currently have an existing infrastructure or owner. We are doing lots of work to understand these ideas and determine ways to address them over time post-close.

Question: What do you see as the key challenges and the opportunities for success?

Ellie: Medtronic today is an intentionally decentralized company. We push decision-making to those closest to the customer. This provides a lot of benefits in terms of our ability to serve customers well, however it makes it challenging to do things across the entire organization. Covidien has a number of sophisticated capabilities, processes and tools for cross-company collaboration that we can leverage in the new Medtronic.

Question: Can you provide some examples of growth opportunities post-close?

Ellie: The most obvious opportunity will be our ability to leverage the breadth of the combined company's product portfolio to cross-sell products and services. But we're also very focused on finding new ways to deliver value to strategic partners like governments and health care systems. Our scope and expertise will enable us to do things that no other company in med-tech will be able to do.

Question: **How will you define success?**

David: If in five years the new Medtronic is the clear first choice for customers, patients, providers and also our employees, external innovators and our investors, then I think we will have won.

Ellie: If we've improved clinical outcomes, expanded access and optimized the cost of health care delivery as a result of this transaction, then I will say we've been successful.

Question: **How can Medtronic and Covidien employees contribute?**

David: The most important thing is for all of us to be very engaged. Raise a hand if you have an idea or solution that you believe it is not being pursued. Every one of us can play a part in determining what the future combined company will look like by sharing our thoughts and ideas.
