This Amendment No. 7 to Schedule 13D amends and supplements the Schedule 13D filed by Mark Cuban with the Securities and Exchange Commission (the Commission) on September 22, 2011, as amended by that Schedule 13D/A filed with the Commission on January 23, 2014, as amended by that Schedule 13D/A filed with the Commission on March 27, 2014, as amended by that Schedule 13D/A filed with the Commission on March 28, 2014, as amended by that Schedule 13D/A filed with the Commission on April 3, 2014, as amended by that Schedule 13D/A filed with the Commission on October 27, 2014, as amended by that Schedule 13D/A filed with the Commission on November 4, 2014 (as amended and supplemented, collectively, the Schedule 13D), relating to the Common Stock, par value \$0.001 per share (the Common Stock), issued by Rentrak Corporation (the Issuer). Initially capitalized terms used herein that are not otherwise defined herein shall have the same meanings attributed to them in the Schedule 13D. Except as expressly provided for herein, all Items of the Schedule 13D remain unchanged.

**Item 5. Interest in Securities of the Issuer**

(A) All percentages set forth in this statement are based on 15,204,978 shares of Common Stock reported in the Issuer's Quarterly Report on Form 10-Q for the period ending December 31, 2014 filed with the Securities and Exchange Commission on February 5, 2014. As of the date of the filing of this Schedule 13D, Mr. Cuban is the beneficial owner of 772,900 shares of Common Stock, which represents approximately 5.1% of the shares of Common Stock outstanding.

(B) Mr. Cuban has the sole power to vote or to direct the vote and the sole power to dispose or to direct the disposition of 772,900 shares of Common Stock.
