On March 17, 2015, WSFS Financial Corporation (the Company) issued a press release announcing a three-for-one split in the Company s common stock (WSFS Stock) in the form of a stock dividend of two shares of WSFS Stock for each issued and outstanding share of WSFS Stock. The stock split/dividend is payable to stockholders of record as of May 4, 2015, and is subject to stockholder approval of an increase in the Company s authorized shares of WSFS Stock at the 2015 WSFS Financial Corporation Annual Meeting.
